College of Dentistry / Dental Hygiene

The university offers a baccalaureate degree program, which consists of at least two years (≥ 60 hrs) of prerequisite work and two years in the dental hygiene curriculum. Prerequisite courses may be taken at the University of Oklahoma or other accredited university or college. The College of Dentistry offers the program on the Oklahoma Health Sciences Center campus in Oklahoma City and by distance at the following three sites:

- Tri-County Technology Center in Bartlesville
- Southern Oklahoma Technology Center at Ardmore
- Western Technology Center in Weatherford

Upon successful completion of the program, graduates from all sites receive a Bachelor of Science in dental hygiene and are eligible to take examinations for licensure to practice as registered dental hygienists (RDH). The North Central Association of Colleges and Secondary Schools, Commission on Institutions of Higher Education and the Commission on Dental Accreditation of the American Dental Association accredit the program.

DENTAL HYGIENE PROFESSION

The dental hygienist is a licensed primary health care professional, oral health educator and clinician. The responsibilities of the dental hygienist include preventive services that promote or maintain oral health and therapeutic services, which are clinical treatments designed to arrest or control disease. Educational activities are integral to all aspects of patient care. Quality dental hygiene care requires critical thinking to assess the patient's needs, to determine a dental hygiene diagnosis, to develop individualized patient care, to implement dental hygiene treatment and to evaluate outcomes of dental hygiene treatment. The dental hygienist works closely with and usually under the supervision of a dentist. Most dental hygienists are employed in a dental office; however, dental hygienists can be found in numerous other settings, such as nursing homes and long-term care facilities, hospitals, corporate health facilities, school systems, research centers, state and federal agencies and public health clinics. The RDH may be employed as an educator and/or researcher, as a provider of continuing education seminars, as a researcher conducting or helping to conduct clinical studies and collecting and analyzing scientific data. As volunteers, dental hygienists can be found providing care in dental clinics for those who might not otherwise be able to find or afford care, participating in mission trips or providing educational and preventive services to school children as allowed by the laws of the state.

CAREER OPPORTUNITIES

The U.S. Department of Labor's Bureau of Labor Statistics has projected that employment prospects in dental hygiene are expected to remain excellent. In fact, the dental hygienist profession is expected to be one of the fastest growing occupations through the year 2014. The national median hourly wage in 2010 was \$32.81 and in Oklahoma for 2010 the median hourly wage was \$30.03. There is considerable freedom for hygienists to select work days and hours. Annual salaries for part-time practitioners vary.

ADMISSION REQUIREMENTS

Admission to the Dental Hygiene Program is competitive. Selection is based on the applicant's post-secondary academic record, life experiences and potential for success in a baccalaureate program in dental hygiene. New students are admitted for the fall semester only. All application materials must be submitted by Jan. 15 of the year in which admission is sought. Applicants must:

- be in good standing with the last college or university attended
- take the ACT or SAT and provide individual component scores and composite score
- have a minimum grade-point average of 2.5 on a 4.0 scale with a grade of C or better on all required courses
- have a minimum of 60 semester hours of coursework from an accredited college or university
- ideally applicants should have completed foundational coursework (see prerequisite courses) before the Jan. 15 application deadline. Acceptance is based upon completion of foundational coursework by the end of the spring semester prior to admission. All prerequisite courses, excluding foundational, must be completed by the time the fall semester begins
- applicants must investigate dental hygiene as a career prior to application by spending a minimum of 40 hours observing a dental hygienist. Observation of a dentist does not meet this requirement
- complete a written career statement

ADMISSION REQUIREMENTS (Continued)

- two letters of recommendation from individuals familiar with applicant's success or potential for successful completion of the program
- official transcripts from all colleges or universities attended
- submit a completed University of Oklahoma Health Sciences Center online application that includes the prioritized site(s) for which the applicant wishes to be considered: https://app.applyyourself.com/?id=uok-hs
- if English is the student's second language, a minimum score of 250 is required on the national standardized TOEFL examination.
- if you receive an offer of acceptance into the program, it is contingent upon meeting the required grade of C in all remaining prerequisite coursework and a cumulative GPA of 2.5.

REQUIRED PREREQUISITE COURSEWORK

The following courses completed are required (with a minimum of a C grade) and must be included within the minimum 60 semester hours of study. The course names and numbers are those of the University of Oklahoma. Any exception or substitutions must be approved by the program director or college dean or be listed in the Official Course Substitution Guide of the University of Oklahoma.
