

Dear OUHSC Student:

This letter reviews benefits available to you as part of your Student Health Care (SHC) fee. Student health services (SHS) are provided Monday-Friday, 8:30am-12:00 and 1:30-4:30pm in the Family Medicine Center (FMC) at **900 NE 10th Street, Oklahoma City**. The FMC provides acute and chronic care for injuries and illnesses, as well as routine preventative care, limited number of laboratory tests and X-ray studies in the FMC. Students may arrange appointments for routine needs or an acute illness at the FMC by calling **271-4311**. The FMC staff will make every effort to schedule your appointment at a time that is convenient for you.

During the time that you are enrolled as a student, your SHC fee pays for the following services provided **at the Family Medicine Center:**

➤ ACUTE CARE VISITS	➤ PROFESSIONAL OFFICE CHARGES
➤ CHRONIC ILLNESS MANAGEMENT	➤ IN-HOUSE PROVIDER ORDERED OFFICE LAB AND/OR X-RAY
➤ PREVENTATIVE HEALTH CARE EXAMS	➤ ROUTINE IMMUNIZATIONS (TB, TETANUS, MMR) AFTER ENROLLMENT <u>AT A REDUCED RATE</u>

Services **NOT COVERED** by your SHC fee are as follows:

➤ CARE OF DEPENDENTS	➤ EMERGENCY DEPARTMENT CHARGES
➤ HOSPITALIZATION	➤ CONTRACEPTIVE INJECTIONS OR IMPLANTS
➤ HEPATITIS A & B IMMUNIZATIONS, ANNUAL INFLUENZA, GARDASIL & TRAVEL VACCINES	➤ INFERTILITY AND OBSTETRICAL SERVICES
➤ TITERS AND OTHER NON-DIAGNOSTIC TESTS REQUESTED BY STUDENT OR NON-FMC PROVIDER.	➤ LAB STUDIES AND/OR X-RAYS PERFORMED OUTSIDE OF THE FMC.
➤ CONSULTANT FEES/PHYSICIAN REFERRALS WITH PHYSICIANS ON OR OFF THE OUHSC CAMPUS	➤ CULTURES AND PATHOLOGY SPECIMENS SENT OUTSIDE OF THE FMC
➤ CT SCANS, MRI SCANS AND ULTRASOUNDS	

All new students enrolled after the Fall 2001 semester are required to have a health insurance policy by the Board of Regents. The policy is to remain in effect during the enrollment period. Students may purchase the OUHSC Student Policy or a policy from any other carrier. The FMC staff will request your student ID and insurance card at each visit. A copy of each will be made at each visit. An insurance claim will be filed for services provided to you at FMC. You should not have additional expenses for clinic visits except for charges outlined in the above table. These are generally covered (all or in part) by most health insurance policies. **Any amount not paid by your insurance policy will be your responsibility.**
