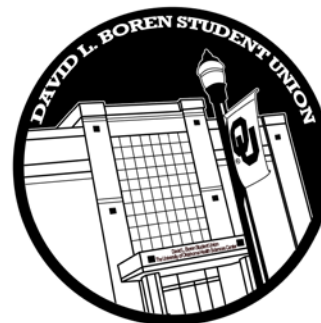

Guidelines for Fundraising/Solicitation in the David L. Boren Student Union for Student Organizations

A fundraising / solicitation permit is required when student organizations are selling merchandise, having a bake sale, distributing information or placing donation boxes in the David L. Boren Student Union. **HSC Student Affairs must approve samples of all products.** Return this completed form to the Student Union Info-Desk, Room 102, at least five (5) working days prior to the solicitation date. The Student Union's first floor corridor is the only approved location for solicitation and the Union staff will decide the booth location daily to fit the needs of the Union's activity.

- Bake Sale
 - Bake sales must be approved by HSC Food Services.
 - Baked goods/desserts must be homemade. No store bought or prepackaged items allowed.

- Donation Box
 - The Student Union is not responsible for monitoring the items donated. It is recommended that student organizations regularly pick up the items during the donation period.

- Merchandise
 - For selling t-shirts or other fundraising items, designs must be attached to the permit. If the product contains registered trademarks (e.g., The University of Oklahoma, OU, Sooners, University Seal), please attach approved paperwork.
